CONTRACT

THIS AGREEMENT, by and between the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the **Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE** (hereinafter called "the Entity") of the one part and **GASAT BUILDERS AND SUPPLIES INC** of Ditale, Dipaculao, Aurora managed by **JHAREL JAY F. PIZARRO** (hereinafter called "the Contractor") of the other part:

WHEREAS, the Entity is desirous that the Contractor execute the projects:

A. CONCRETING OF INOCENCIA AGANA ST. AT BRGY. SAN AGUSTIN; B. CONCRETING OF PUROK 1 ROAD AT BRGY. DIRITA; C. CONCRETING OF PUROK 2 ROAD AT BRGY. DIRITA; D. CONSTRUCTION OF SLOPE PROTECTION / GROUTED RIPRAP AT TUGUE ROAD BRGY. ZONE 1; E. CONCRETING OF BENJAMINE FARIN SR. ST. PHASE II AT BRGY. ZONE 1. (Hereinafter called "the Works") and the Entity has accepted the Bid for project in the amount of:

A. TWO MILLION ONE HUNDRED NINETY-TWO THOUSAND NINE HUNDRED THIRTEEN PESOS AND FIVE CENTAVOS (P2,192,913.05); B. ONE MILLION NINE HUNDRED EIGHTY-EIGHT THOUSAND THREE HUNDRED FOUR PESOS AND FORTY-EIGHT CENTAVOS (P1,988,304.48); C. THREE MILLION ONE HUNDRED EIGHTY-SIX THOUSAND FOUR HUNDRED NINETY-SIX PESOS AND FIFTY-NINE CENTAVOS (P3,186,496.59); D. EIGHT HUNDRED SEVENTEEN THOUSAND SEVEN HUNDRED NINETY-NINE PESOS AND FORTY-NINE CENTAVOS (P817,799.49); E. THREE HUNDRED SIXTEEN THOUSAND FOUR HUNDRED SIXTY-TWO PESOS AND FIFTY-NINE CENTAVOS (P316,462.59); by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Apply for Eligibility and to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Credit line issued by a licensed bank, if any;
 - (l) Notice of Award of Contract and the Bidder's conforme thereto;
 - (m) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the

Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.


- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


