C O N T R A C T

THIS CONTRACT made by and between the government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, **HON. IRENEA MANQUIZ - BINAN** (hereinafter called "the Entity") of the one part and **NISSAN COMMONWEALTH, INC.** represented by its Account Specialist **DENNIS D. BUNTAN** with registered office address at 41 Commonwealth Ave., Brgy. Holy Spirit, QC, Metro Manila (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the Bids for purchase/acquisition of goods, viz., "**PURCHASE OF PICK-UP TYPE VEHICLE FOR DISASTER RESPONSE, RESCUE/RELIEF OPERATIONS INTENDED FOR MOBILITY PURPOSES AND IMMEDIATE RESPONSE DURING DISASTERS AND CALAMITIES**" (herein after called "the Contract") as stated in the Invitation to Bid and has accepted a Bid by the Contractor of the supply and delivery of the said goods/product with the sum of **One Million Nine Hundred Ninety-Eight Thousand Pesos and 00/100 (P1,998,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (a) the Bid Form and the Price Schedule submitted by the Bidder;
- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract; and
- (f) the Entity's Notification of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


IN WITNESS, whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Philippines on the day and year first above written.




