C O N T R A C T

THIS CONTRACT made this 16th day of September 2018 by and between;

The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and *Q3 Variety Store* represented by its owner PHILLIP A. TREESUTHAMMARD with registered store address at Zone 1, Iba, Zambales (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the Bids for purchase/acquisition of goods, viz Emergency Purchase of Food Commodities for affected areas of Iba, Zambales brought by typhoon Ompong (herein after called "the Contract") in the amount of **Four Hundred Eighty Five Thousand Seven Hundred Seventy-Five Pesos and 00/100 (P 485,775.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) the declaration of State of Calamity by Sanguniang Bayan of Iba (Referendum Resolution No. 1 Series of 2018);
- (b) the Executive Order (EO No. 2018-011) directing the BAC to procure relief goods for the affected families of typhoon Ompong;
DIRECTING THE BIDS AND AWARDS COMMITTEE TO PROCURE RELIEF GOODS FOR THE AFFECTED FAMILIES OF TYPHOON OMPONG;
- (c) the BAC Resolution dated January 5, 2018;
- (d) the BAC Resolution dated September 15, 2018;
- (e) Purchase Request;
- (f) Purchase Order; and
- (g) Other documents included in the transaction in accordance with Section 53.2 and Annex H of IRR of RA 9184.



The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS, whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Philippines on the day and year first above written.


