

CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT OF SERVICE** ("CONTRACT") is made and entered into this _____ day _____ 2022 by and between:

Municipality of Iba, Zambales, a Local Government Unit of the Republic of the Philippines, with public office address located at R. Magsaysay Ave., Zone 1, Iba, Zambales, herein represented by its *Local Chief Executive*, **Hon. IRENEA MANQUIZ-BINAN**, hereinafter referred to as buyer;

- and -

I.L. FERNANDO GENERAL MERCHANDISE, with office address and principal place of business located at #62 Scout, Madrinan St. South Triangle, Quezon City herein represented by its *Owner*, **IRWIN L. FERNANDO** hereinafter referred to as supplier;

WITNESSETH: That -

WHEREAS, in this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

WHEREAS, the following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) the Bid Form and the Price Schedule submitted by the Bidder;
- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract; and
- (f) the Entity's Notification of Award.

WHEREAS, the office of the Sangguniang Bayan of Iba, Zambales approved Ordinance No. 10, Series of 2022 "ESTABLISHING AND INSTITUTIONALIZING THE RICE SUBSIDY PROGRAM TO EACH FAMILY IN THE MUNICIPALITY OF IBA, ZAMBALES;"

WHEREAS, the Ordinance aims to provide each family in the municipality of Iba, Zambales a RICE SUBSIDY through a discounted price of rice which shall be during lean months of September and October every year to cushion the impact of inflation and rice shortage;

WHEREAS, the RICE SUBSIDY PROGRAM is designed as a Cost Sharing Scheme between LGU-Iba and Ibanian family beneficiaries wherein the latter shall pay the fixed amount of 20 pesos per kilo of rice to be collected by the distribution team and shall be remitted to the rice supplier. The rest of the expense (contract price) shall be borne by the Local Government Unit of Iba, Zambales;

WHEREAS, under the RICE SUBSIDY PROGRAM, the contract price for every delivered 25 kilograms sack of rice is amounting to Nine Hundred Ninety-Five Pesos (P 995.00), wherein the Local Government Unit of Iba shall pay to the supplier the amount of Four Hundred Ninety-Five Pesos (P495.00) while the rest of the amount equivalent to Five Hundred Pesos (P 500.00) shall be paid by each Ibanian Family beneficiaries who avail of the program.

WHEREAS, Local Government Unit of Iba, Zambales invited bids for **SUPPLY AND DELIVERY OF RICE FOR RICE SUBSIDY PROGRAM OF LGU-IBA, ZAMBALES** and the bid of **I.L. FERNANDO GENERAL MERCHANDISE** has been found to be the **SINGLE CALCULATED AND RESPONSIVE BIDDER**.
