CONTRACT

THIS AGREEMENT, made this 14th day of December, 2018 between **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** with address at the Municipal Hall, R. Magsaysay Ave., Brgy. Zone I, Iba, Zambales herein represented by its Local Chief Executive, Mayor Jun Rundstedt C. Ebdane (hereinafter called the "Entity") and **GMR CONSTRUCTION & SUPPLY** with address at Brgy. Dirita/Baloguen, Iba, Zambales herein represented by its Owner/Manager, Austerio G. Ruanto (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **INFRA 2018-018 : CONSTRUCTION OF STORAGE AND REFURBISHMENT OF TOILET AND BATH ALONG ACCOUNTING AND HR OFFICE** (hereinafter called "the Works") and the Entity has accepted the Bid for **Three Hundred Twenty Seven Thousand Five Hundred Thirteen & 38/100 Pesos (PhP 327,513.38)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor






