**C O N T R A C T**

THIS CONTRACT made this 25<sup>th</sup> day of January 2019 by and between;

The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and *TIME TRAVEL TOURS & SERVICES* represented by its owner LOURD CHRISTOPHER D. GAMIDO with registered office address at Palanginan, Iba, Zambales (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the Bids for purchase/acquisition of goods, viz "*LEASE OF VENUE INCLUSIVE OF TRANSPORTATION FOR 112 MUNICIPAL EMPLOYEES AND OFFICIALS*" (herein after called "the Contract") as stated in the Invitation to Bid and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Eight Hundred Fifty-One Thousand Two Hundred and 00/100 pesos (P/ 851,200.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- (a) the Bid Form and the Price Schedule submitted by the Bidder;
- (b) the Schedule of Requirements;
- (c) the Technical Specifications;
- (d) the General Conditions of Contract;
- (e) the Special Conditions of Contract;
- (f) the Performance Security; and
- (g) the Entity's Notice of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


