THIS CONTRACT made this 6th day of March 2019 by and between;

The government of the Republic of the Philippines through the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, **HON. JUN RUNDSTEDT C. EBDANE** (hereinafter called "the Entity") of the one part and **KAE CONSTRUCTION AND SUPPLY** represented by its owner **KENNITH ANTHONY T. EBUENGAN** with registered office address at Poblacion, Candelaria, Zambales (hereinafter called "the Contractor") of the other part.

WHEREAS the Entity published/invited the Bids for purchase/acquisition of goods, viz., **SUPPLY & DELIVERY OF MATERIALS FOR LIVELIHOOD PROGRAM OF DOLE & PESO (CONCRETE POTS MAKING, TOKWA MAKING & HANDICRAFT MAKING)** (herein after called "the Contract") as stated in the Invitation to Bid and has accepted a Bid by the Contractor of the supply and delivery of the said goods/product with the sum of **Three Hundred Thirty-Two Thousand Six Hundred Twenty-Five and 00/100 pesos (P/ 332,625.00)** (hereinafter called "the Contract Price").

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (a) the Bid Form and the Price Schedule submitted by the Bidder;


