### CONTRACT

THIS AGREEMENT, made this 12<sup>th</sup> day of February, 2019 between the LOCAL GOVERNMENT UNIT OF IBA, Zambales, Philippines represented herein by the Municipal Mayor, HON. JUN RUNDSTEDT C. EBDANE (hereinafter called "the Entity") of the one part and G.M.R. CONSTRUCTION & SUPPLY of Iba, Zambales owned by AUSTERIO G. RUANTO (hereinafter called "the Contractor") of the other part:

WHEREAS, the Entity is desirous that the Contractor execute "**A. CONCRETING OF 197 LM PUROK 3 BRGY. ROAD AT BRGY. STO. ROSARIO, IBA, ZAMBALES; B. CONCRETING OF 197 LM PUROK 4 BRGY. ROAD AT BRGY. STO. ROSARIO, IBA, ZAMBALES; C. CONCRETING OF 438.30 LM S. SARMIENTO ST. ROAD / PAMPLONA AT BRGY. AMUNGAN, IBA, ZAMBALES**" (hereinafter called "the Works") and the Entity has accepted the Bid for *Lot A. One Million Two Hundred Fifty Four Thousand Three Hundred Seventy Three Pesos and 39/100 (P1,254,373.39); for Lot B. One Million One Hundred Thirteen Thousand Nine Hundred Seventy Eight Pesos and 78/100 (P1,113,978.78); for Lot C. Three Million One Hundred Four Thousand Nine Hundred Sixty-Five Pesos and 55/100 (P 3,104,965.55)* respectively by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) General and Special Conditions of Contract;
  - (b) Drawings/Plans;
  - (c) Specifications;
  - (d) Invitation to Apply for Eligibility and to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Credit line issued by a licensed bank, if any;
  - (l) Notice of Award of Contract and the Bidder's conforme thereto;
  - (m) Other contract documents that may be required by existing laws and/or the Entity.

- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
