**BAC Resolution Recommending the Award of Project "SAFE CLOSURE OF MUNICIPALITY'S TEMPORARY GARBAGE COLLECTING PICK-UP POINT AREA (INFRA 2017-018)" to GMR. CONSTRUCTION AND SUPPLY**

**RESOLUTION NO. INFRA I2017-017**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "SAFE CLOSURE OF MUNICIPALITY'S TEMPORARY GARBAGE COLLECTING PICK-UP POINT AREA" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated October 30 to November 25, 2017;

WHEREAS, in response to the said advertisements, three (3) bidders paid the bid documents fee, they are Jorgz Konztrak and Supply of Iba, Zambales, GMR. Construction and Supply of Iba Zambales and Bancal Construction and Supply of Botolan Zambales. However, Bancal Construction and Supply failed to submit its bid on time hence it was rejected by the BAC Secretariat;

WHEREAS, the bid proposal G.M.R. CONSTRUCTION & SUPPLY met the requirements and criteria during bid opening dated November 20, 2017 while the bid of JORGZ KONZTRAK & SUPPLY is ranked second lowest bid during the bid opening;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds G.M.R. CONSTRUCTION & SUPPLY bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring G.M.R. CONSTRUCTION & SUPPLY to pass their post qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."
