BAC Resolution Recommending the Award of Project “SUPPLY AND DELIVERY OF VARIOUS SCHOOL SUPPLIES FOR DISTRIBUTION TO ELEMENTARY AND DAYCARE PUPILS OF MUNICIPALITY OF IBA, ZAMBALES (GOODS 2019-006)” to I.L. FERNANDO GENERAL MERCHANDIZE

RESOLUTION NO. GOODS G2019-006

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for “SUPPLY AND DELIVERY OF VARIOUS SCHOOL SUPPLIES FOR DISTRIBUTION TO ELEMENTARY AND DAYCARE PUPILS OF MUNICIPALITY OF IBA, ZAMBALES” in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated May 18-June 10, 2019;

WHEREAS, in response to the said advertisements, two bidders participated in the bidding namely, ANB ENTERPRISES from Zone V, Iba, Zambales and I.L. FERNANDO GENERAL MERCHANDIZE from #62 Scout Medrianan St. South Triangle, Quezon City. Both paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the bid proposals of ANB ENTERPRISES and I.L. FERNANDO GENERAL MERCHANDIZE met the requirements and criteria during bid opening dated June 10, 2019;

WHEREAS, the bid proposals of I.L. FERNANDO GENERAL MERCHANDIZE passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Lowest Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds I.L. FERNANDO GENERAL MERCHANDIZE bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring I.L. FERNANDO GENERAL MERCHANDIZE having passed their post qualification evaluation;

WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”


NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.




