BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF OFFICE AND JANITORIAL SUPPLIES FOR VARIOUS OFFICES OF LGU-IBA, ZAMBALES (GOODS 2019-007)" to VMD TRADING

RESOLUTION NO. GOODS G2019-007

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "SUPPLY AND DELIVERY OF OFFICE AND JANITORIAL SUPPLIES FOR VARIOUS OFFICES OF LGU-IBA, ZAMBALES" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated May 26-June 3, 2019;

WHEREAS, in response to the said advertisements, only VMD TRADING from Zone V, Iba, Zambales, paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the bid proposal of VMD TRADING met the requirements and criteria during bid opening dated June 3, 2019;

WHEREAS, having only one bid proposal which passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds VMD TRADING bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring VMD TRADING having passed their post qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:






