BAC Resolution Recommending the Award of Project “1. Concreting of 250 LM Merindo St. at Brgy. Amungan, Iba, Zambales; 2. Concreting of 173.33 LM Purok 4, at Brgy. San Agustin, Iba, Zambales; 3. Concreting of 300 LM Posadas St. at Brgy. Palanginan, Iba, Zambales; and 4. Concreting of 142 LM Bundang St. at Zone VI, Iba, Zambales (INFRA 2018-001)” to GMR Construction and Supply

RESOLUTION NO. INFRA I2018-001

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for Lots 1. Concreting of 250 LM Merindo St. at Brgy. Amungan, Iba, Zambales; 2. Concreting of 173.33 LM Purok 4, at Brgy. San Agustin, Iba, Zambales; 3. Concreting of 300 LM Posadas St. at Brgy. Palanginan, Iba, Zambales; and 4. Concreting of 142 LM Bundang St. at Zone VI, Iba, Zambales (INFRA 2018-001) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated March 28 to April 3, 2018;

WHEREAS, in response to the said advertisements, only two intentions to bid were submitted, first is from JORGZ KONZTRAK AND SUPPLY from Lipay Dingin, Iba, Zambales and GMR Construction and Supply from Dirita, Iba, Zambales complete with proof of payment of bid documents fee;

WHEREAS, both bid proposal met the requirements and criteria during bid opening dated April 16, 2018;

WHEREAS, the bid proposal of GMR Construction and Supply passed requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Lowest Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds GMR Construction and Supply bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR Construction and Supply to pass their post qualification evaluation;

WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:




- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.




