BAC Resolution Recommending the Award of Project "PURCHASE OF DAY CARE INSTRUCTIONAL MATERIALS (GOODS 2018-005)" to ANB ENTERPRISES

RESOLUTION NO. GOODS G2018-005

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "PURCHASE OF DAY CARE INSTRUCTIONAL MATERIALSin three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated July 24-31, 2018;

WHEREAS, in response to the said advertisements, only ANB ENTERPRISES from Zone VI, Iba, Zambales, paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the bid proposal ANB ENTERPRISES met the requirements and criteria during bid opening dated July 31, 2018;

WHEREAS, having only one bid proposal which pass requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds ANB ENTERPRISES bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring ANB ENTERPRISES having passed their post qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project PURCHASE OF DAY CARE INSTRUCTIONAL MATERIALS under project reference No. Goods 2018-005 to ANB ENTERPRISES from Zone VI, Iba, Zambales.
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.
