**BAC Resolution Recommending the Award of Project “SUPPLY AND DELIVERY OF MEDICINES FOR RURAL HEALTH UNIT OF LGU-IBA, ZAMBALES (GOODS 2018-003)” to JJKHALID DRUG DISTRIBUTOR**

**RESOLUTION NO. GOODS G2018-003**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for SUPPLY AND DELIVERY OF MEDICINES FOR RURAL HEALTH UNIT OF LGU-IBA, ZAMBALES (GOODS 2018-003) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated May 16-23, 2018;

WHEREAS, in response to the said advertisements, four intentions to bid were submitted, first is from ELOHIM PHARMA from 40 Road 13, PAG-ASA, Quezon City; DANE DEGALA CASTILLO PHARMACY from Zone VI, Iba, Zambales; JJKHALID DRUG DISTRIBUTOR from St. Anne Cupang Proper Balanga City, Bataan; and CGMP MEDICAL DISTRIBUTOR from 51 San Miguel Drive Cortejos De San Rafael Rizal, complete with proof of payment of bid documents fee;

WHEREAS, all bid proposal except from CGMP MEDICAL DISTRIBUTOR met the requirements and criteria during bid opening dated June 5, 2018;

WHEREAS, the bid proposal of JJKHALID DRUG DISTRIBUTOR passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Lowest Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds JJKHALID DRUG DISTRIBUTOR bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring JJKHALID DRUG DISTRIBUTOR to pass their post qualification evaluation;

WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.




