BAC Resolution Recommending the Award of Project “SUPPLY AND DELIVERY OF MEDICINES AND FIRST AID KIT USE FOR LDRRM (GOODS 2018-018)” to JJKHALID DRUG DISTRIBUTOR

RESOLUTION NO. GOODS G2018-018

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for SUPPLY AND DELIVERY OF MEDICINES AND FIRST AID KIT USE FOR LDRRM (GOODS 2018-018) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated November 14-21, 2018;

WHEREAS, in response to the said advertisements, five (5) bid document requests were made in the PhilGEPS but only one intention to bid was submitted. The sole bid submission was from JJKHALID DRUG DISTRIBUTOR of St. Anne Cupang Proper Balanga City, Bataan; complete with proof of payment of bid documents fee;

WHEREAS, the bid proposal of JJKHALID DRUG DISTRIBUTOR met the requirements and criteria during bid opening dated November 21, 2018;

WHEREAS, the bid proposal of JJKHALID DRUG DISTRIBUTOR passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds JJKHALID DRUG DISTRIBUTOR bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring JJKHALID DRUG DISTRIBUTOR to pass their post qualification evaluation;

WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Project “SUPPLY AND DELIVERY OF MEDICINES AND FIRST AID KIT USE FOR LDRRM (GOODS 2018-018)” to JJKHALID DRUG DISTRIBUTOR.
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.
