BAC Resolution Declaring DOÑA JOVITA GARDEN RESORT as the Lowest Calculated and Responsive Quotation and its Award for the project Team Building Workshop of 125 Employees of LGU Iba, Zambales at Panzol, Calamba, Laguna and Recommending for the Approval of the Head of Procuring Entity

RESOLUTION NO. 2018-LOV-01

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA thru its Human Resource Officer V (HRMO V), Mrs. Teresita R. Lising, has planned to conduct a Team Building Workshop of 125 employees of LGU-Iba, Zambales at Panzol, Calamba, Laguna on March 23-25, 2018.

WHEREAS, the BAC thoroughly considered and evaluated the proposal the HRMO V and has agreed that the best mode of procurement as provided in 2016 IRR of RA 9184 is the Negotiated Procurement – Lease of Venue.

WHEREAS, HRMO V justified the resort to lease of privately owned venue against that of government owned venue since there were no available government venue that can accommodate the needs of the said project.

WHEREAS, the Approved Budget for the above Contract of is Four Hundred Thousand Pesos and 00/100 (P/ 400,000.00);

WHEREAS, the Technical Specification and Request for Quotation were sent to at least three prospective suppliers of known qualification to determine which among the available venues is cost advantageous to the government and can accommodate the needs of the project.

WHEREAS, Section 53.10 of the 2016 IRR of RA 9184 (Government Procurement Reform Act) allows the procuring entity to resort to Negotiated Procurement for leasing a privately-owned venue for official use provided that the end-user complied with the required procedural requirements of GPPB.

WHEREAS, based on the result of the Cost-Benefit Analysis, the End-user recommended to lease a privately-owned venue within Calamba, Laguna, since privately owned venue and facilities can comply with the requirement of the project.

WHEREAS, the evaluation of all submitted documents shows that DOÑA JOVITA GARDEN RESORT is the only resort which have a function room that can accommodate 125 persons, and also the Lowest Price Quotation submitted to the BAC.

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) That DOÑA JOVITA GARDEN RESORT as the Lowest Calculated and Responsive Quotation;
- b) To recommend the award of the project Team Building Workshop of 125 Employees of LGU Iba, Zambales at Panzol, Calamba, Laguna on March 23-25, 2018;

- c) To recommend the approval of this resolution to the Municipal Mayor of Local Government Unit of Iba, Zambales the foregoing findings.


