WHEREAS, only one (1) prospective suppliers responded to the request for quotation for the above-mentioned project. HANOKI PHILIPPINES INCORPORATED of Tarlac City, Tarlac submitted its Technical/Eligibility Requirement as required by BAC and the Quotation which shall be an integral part of the required financial documents to be submitted.

WHEREAS, said supplier submitted their technical and financial documents in sealed enveloped on April 6, 2018 but was rescheduled to open on April 16, 2018 due to non-quorum.

WHEREAS, upon preliminary evaluation of the proposal of HANOKI PHILIPPINES INCORPORATED, it was found that it is substantially complying with the requirements of RA 9184, the requirements of the BAC, did not exceed the ABC for the project and is declared the single calculated and responsive quotation for the above mentioned project.

WHEREAS, the detailed Evaluation of the documents required for Two Failed Bidding and the proposal of HANOKI PHILIPPINES INCORPORATED conducted on the same date resulted in the following:


