BAC Resolution Recommending the Award of Project "CORE LOCAL ACCESS ROAD IN BRGY. AMUNGAN, IBA, ZAMBALES (LOCAL ROAD UPGRADING OF 1,301.16 LM PORTION OF ROAD AT BRGY. AMUNGAN, IBA, ZAMBALES)" to JORGZ KONZTRAK & SUPPLY

RESOLUTION NO. INFRA I2018-008

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for **CORE LOCAL ACCESS ROAD IN BRGY. AMUNGAN, IBA, ZAMBALES (LOCAL ROAD UPGRADING OF 1,301.16 LM PORTION OF ROAD AT BRGY. AMUNGAN, IBA, ZAMBALES (INFRA 2018-008)** in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for twenty (20) days dated January 8 – 28, 2019;

WHEREAS, in response to the said advertisements, two intentions to bid were submitted, one is from GMR CONSTRUCTION AND SUPPLY; and another from JORGZ KONZTRAK AND SUPPLY; complete with proof of payment of bid documents fee;

WHEREAS, all bid proposals met the requirements and criteria during bid opening dated January 28, 2019.

WHEREAS, the bid of GMR Construction and Supply was declared highest calculated bid while that of JORGZ KONZTRAK AND SUPPLY was declared Lowest Calculated bid upon recommendation of TWG;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds JORGZ KONZTRAK AND SUPPLY bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring JORGZ KONZTRAK AND SUPPLY to pass their post qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of


