PALANGINAN IBA, ZAMBALES AND BRGY. BANCAL BOTOLAN, ZAMBALES" to GMR CONSTRUCTION & SUPPLY**

### RESOLUTION NO. INFRA I2020-05

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the project "A. CONCRETING OF 250 LM F. ABADAM ST. (ALVIOR) AT BRGY. AMUNGAN, IBA, ZAMBALES; B. CONSTRUCTION OF 305 LM LINED CANAL ALONG CAMAGONG STREET, PUROK 2, BRGY. STA. BARBARA and C. DREDGING OF BANCAL RIVER MOUTH IN BETWEEN BRGY. PALANGINAN IBA, ZAMBALES AND BRGY. BANCAL BOTOLAN, ZAMBALES" (INFRA 2020-05) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for (20) days dated May 11, 2020 to June 1, 2020;

WHEREAS, in response to the said advertisements, two bid documents were submitted, first is from JORGZ KONZTRAK & SUPPLY then from GMR CONSTRUCTION & SUPPLY; all bidders paid the bid documents fee;

WHEREAS, the bid proposal of both bidders met the requirements and criteria during bid opening dated June 01, 2020;

WHEREAS, upon recommendation of TWG, the bid proposal of JORGZ KONZTRAK & SUPPLY was declared lowest calculated bid for the projects "A. CONCRETING OF 250 LM F. ABADAM ST. (ALVIOR) AT BRGY. AMUNGAN, IBA, ZAMBALES and B. CONSTRUCTION OF 305 LM LINED CANAL ALONG CAMAGONG STREET, PUROK 2, BRGY. STA. BARBARA" while GMR CONSTRUCTION & SUPPLY was declared lowest calculated bid for the project "C. DREDGING OF BANCAL RIVER MOUTH IN BETWEEN BRGY. PALANGINAN IBA, ZAMBALES AND BRGY. BANCAL BOTOLAN, ZAMBALES";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds JORGZ KONZTRAK & SUPPLY and GMR CONSTRUCTION & SUPPLY documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring JORGZ KONZTRAK & SUPPLY and GMR CONSTRUCTION & SUPPLY to pass the post qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED.

- a) To recommend the AWARDS of the Projects "A. CONCRETING OF 250 LM F. ABADAM ST. (ALVIOR) AT BRGY. AMUNGAN, IBA, ZAMBALES and B. CONSTRUCTION OF 305 LM LINED CANAL ALONG CAMAGONG STREET, PUROK 2, BRGY. STA. BARBARA" to JORGZ KONZTRAK & SUPPLY.
- b) To recommend the AWARD of the Project "C. DREDGING OF BANCAL RIVER MOUTH IN BETWEEN BRGY. PALANGINAN IBA, ZAMBALES AND BRGY. BANCAL BOTOLAN, ZAMBALES" to GMR CONSTRUCTION & SUPPLY;
- c) To recommend to the Municipal Mayor of Local Government Unit of Iba the approval of the foregoing findings.


