SAN AGUSTINE, IBA, ZAMBALES" to LEO-J. CONSTRUCTION SERVICES

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the project "A. CONCRETING OF 575 LM BUAN ST. (HABANG FISHPORT-MARKET ROAD) AT PUROK 10, SITIO LANAO, BRGY. SAN AGUSTINE, IBA, ZAMBALES" and "B. CONSTRUCTION OF REINFORCE CONCRETE BOX CULVERT (RCBC) SINGLE BARREL - (2.40M X 2.40M X 5.0M) AT PUROK 1, SITIO LANAO, BRGY. SAN AGUSTINE, IBA, ZAMBALES" (INFRA 2019-012) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for (20) days dated October 28 to November 18, 2019;

WHEREAS, in response to the said advertisements, three bid documents were submitted, first is from GMR CONSTRUCTIONS AND SUPPLY; then from LEO J CONSTRUCTION SERVICES; and the other is from VM BUILDERS CONSTRUCTION; all bidders paid the bid documents fee;

WHEREAS, the bid proposals of the three contractors met the requirements and criteria during bid opening dated November 18, 2019;

WHEREAS, upon recommendation of TWG, the bid proposal of GMR CONSTRUCTION AND SUPPLY was declared lowest calculated bid for the project A. CONCRETING OF 575 LM BUAN ST. (HABANG FISHPORT-MARKET ROAD) AT PUROK 10, SITIO LANAO, BRGY. SAN AGUSTINE, IBA, ZAMBALES while the bid proposal of LEO-J. CONSTRUCTION SERVICES was declared lowest calculated bid for the project B. CONSTRUCTION OF REINFORCE CONCRETE BOX CULVERT (RCBC) SINGLE BARREL - (2.40M X 2.40M X 5.0M) AT PUROK 1, SITIO LANAO, BRGY. SAN AGUSTINE, IBA, ZAMBALES;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds GMR CONSTRUCTION AND SUPPLY and LEO - J CONSTRUCTION SERVICES documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR CONSTRUCTION AND SUPPLY and LEO - J CONSTRUCTION SERVICES to pass the post qualification evaluation;



NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


