BAC Resolution Recommending the Award of The Project "CONCRETING OF 230 LM DANAC STREET WITH LINE CANAL AT BRGY. ZONE 5, IBA, ZAMBALES" to GMR CONSTRUCTION & SUPPLY

RESOLUTION NO. INFRA I2020-07

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the project "CONCRETING OF 230 LM DANAC STREET WITH LINE CANAL AT BRGY. ZONE 5, IBA, ZAMBALES" (INFRA 2020-07) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for (20) days dated August 13, 2020 to September 1, 2020;

WHEREAS, in response to the said advertisements, three bid documents were submitted, first is from JORGZ KONZTRAK & SUPPLY, second is from LEO - J CONSTRUCTION SERVICES, lastly is from GMR CONSTRUCTION & SUPPLY; all bidders paid the bid documents fee;

WHEREAS, the bid proposal of both bidders met the requirements and criteria during bid opening dated September 01, 2020;

WHEREAS, upon recommendation of TWG, the bid proposal of GMR CONSTRUCTION & SUPPLY was declared single calculated bid for the project "CONCRETING OF 230 LM DANAC STREET WITH LINE CANAL AT BRGY. ZONE 5, IBA, ZAMBALES";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds GMR CONSTRUCTION & SUPPLY documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR CONSTRUCTION & SUPPLY to pass the post qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Project "CONCRETING OF 230 LM DANAC STREET WITH LINE CANAL AT BRGY. ZONE 5, IBA, ZAMBALES" to GMR CONSTRUCTION & SUPPLY.
- b) To recommend to the Municipal Mayor of Local Government Unit of Iba the approval of the foregoing findings.

RESOLVED at the Office of the Bids and Awards Committee this September 17, 2020.






