BAC Resolution Recommending the Award of Project “CONSTRUCTION OF 320 LM DRAINAGE CANAL AT BRGY. ZONE 1, AND BALOQUEN, IBA, ZAMBALES” to JORGZ KONZTRAK & SUPPLY

RESOLUTION NO. INFRA I2018-014

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for **CONSTRUCTION OF 320 LM DRAINAGE CANAL AT BRGY. ZONE 1, AND BALOQUEN, IBA, ZAMBALES** (INFRA 2018-014) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated October 12 – November 31, 2018;

WHEREAS, in response to the said advertisements, two intentions to bid were submitted, first is from JORGZ KONZTRAK & SUPPLY; second is from GMR Construction and Supply and lastly from Markbilt Construction; complete with proof of payment of bid documents fee;

WHEREAS, the bid proposals of JORGZ KONZTRAK & SUPPLY and GMR Construction and Supply met the requirements and criteria during bid opening dated October 31, 2018. The bid proposal of Markbilt Construction was declared ineligible due to lacking requirement;

WHEREAS, the bid proposals of JORGZ KONZTRAK & SUPPLY and GMR Construction and Supply both passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared JORGZ KONZTRAK & SUPPLY as the lowest calculated bid while the bid of GMR Construction and Supply is declared highest calculated bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds JORGZ KONZTRAK & SUPPLY bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring JORGZ KONZTRAK & SUPPLY to pass their post qualification evaluation;


WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.






