BAC Resolution Recommending the Award of Project "CONSTRUCTION OF 345 LM DRAINAGE LINE CANAL AT BRGY. STA. BARBARA, IBA, ZAMBALES" to GMR CONSTRUCTION AND SUPPLY

RESOLUTION NO. INFRA I2019-013

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the project "CONSTRUCTION OF 345 LM DRAINAGE LINE CANAL AT BRGY. STA. BARBARA, IBA, ZAMBALES" (INFRA 2019-013) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for (20) days dated October 29 to November 19, 2019;

WHEREAS, in response to the said advertisements, three bid documents were submitted, first is from GMR CONSTRUCTIONS AND SUPPLY; then from LEO J CONSTRUCTION SERVICES; and the other is from VM BUILDERS CONSTRUCTION; all bidders paid the bid documents fee;

WHEREAS, the bid proposals of the three contractors met the requirements and criteria during bid opening dated November 19, 2019;

WHEREAS, upon recommendation of TWG, the bid proposal of GMR CONSTRUCTION AND SUPPLY was declared lowest calculated bid for the project *CONSTRUCTION OF 345 LM DRAINAGE LINE CANAL AT BRGY. STA. BARBARA, IBA, ZAMBALES*;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds GMR CONSTRUCTION AND SUPPLY documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR CONSTRUCTION AND SUPPLY to pass the post qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To recommend to the Municipal Mayor of Local Government Unit of Iba the approval of the foregoing findings.



4. Interested bidders may obtain further information from LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES and inspect the Bidding Documents at the address given below from 9:00 a.m. - 4:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested bidders on October 29, 2019 to November 18, 2019 at the Office of Bids and Awards Committee, Municipal Hall, R. Maguway Ave., Zone I, Iba, Zambales and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P 5,000.00). It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The Local Government Unit of Iba, Zambales will hold a Pre-Bid Conference on November 5, 2019, 10:00 a.m. at Conference Room, 1st Floor, Municipal Hall, R. Maguway Ave., Zone I, Iba, Zambales, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before November 18, 2019, 10:00 a.m. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITR Clause 1.2.
