**BAC Resolution Recommending the Award of Project “LEASE OF VENUE INCLUSIVE OF TRANSPORTATION FOR 112 MUNICIPAL EMPLOYEES AND OFFICIALS (GOODS 2019-002)” to TIME TRAVEL TOURS & SERVICES**

**RESOLUTION NO. GOODS G2019-002**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for “LEASE OF VENUE INCLUSIVE OF TRANSPORTATION FOR 112 MUNICIPAL EMPLOYEES AND OFFICIALS” in three (3) conspicuous places of Municipality of Iba in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated January 11-18, 2019;

WHEREAS, in response to the said advertisements, only TIME TRAVEL TOURS & SERVICES from Palanginan, Iba, Zambales, paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the bid proposal of TIME TRAVEL TOURS & SERVICES met the requirements and criteria during bid opening dated January 18, 2019;

WHEREAS, having only one bid proposal which pass requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds TIME TRAVEL TOURS & SERVICES bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring TIME TRAVEL TOURS & SERVICES having passed their post qualification evaluation;


WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.






