BAC Resolution Recommending the Award of Project "SLOPE PROTECTION AND REPAIR OF 450.0 L.M. GRAVEL ROAD FOR THE REHABILITATION OF THE OLD DUMPSITE AT BRGY. BANGANTALINGA, IBA, ZAMBALES" to GMR CONSTRUCTION AND SUPPLY

RESOLUTION NO. INFRA I2020-02

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the project "SLOPE PROTECTION AND REPAIR OF 450.0 L.M. GRAVEL ROAD FOR THE REHABILITATION OF THE OLD DUMPSITE AT BRGY. BANGANTALINGA, IBA, ZAMBALES" (INFRA 2020-02) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for (20) days dated December 28, 2019 to January 16, 2020;

WHEREAS, in response to the said advertisements, only one bid document was submitted which is from GMR CONSTRUCTIONS AND SUPPLY; the single bidder paid the bid documents fee;

WHEREAS, the bid proposal of GMR CONSTRUCTION AND SUPPLY met the requirements and criteria during bid opening dated January 16, 2020;

WHEREAS, upon recommendation of TWG, the bid proposal of GMR CONSTRUCTION AND SUPPLY was declared single calculated bid for the project *SLOPE PROTECTION AND REPAIR OF 450.0 L.M. GRAVEL ROAD FOR THE REHABILITATION OF THE OLD DUMPSITE AT BRGY. BANGANTALINGA, IBA, ZAMBALES*;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds GMR CONSTRUCTION AND SUPPLY documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report, declaring GMR CONSTRUCTION AND SUPPLY to pass the post qualification evaluation declaring as the Single Calculated and Responsive Bid;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project "SLOPE PROTECTION AND REPAIR OF 450.0 L.M. GRAVEL ROAD FOR THE REHABILITATION OF THE OLD DUMPSITE AT BRGY. BANGANTALINGA, IBA, ZAMBALES" to GMR Construction and Supply;
- b) To recommend to the Municipal Mayor of Local Government Unit of Iba the approval of the foregoing findings.
