BAC Resolution Recommending the Award of Project "SUPPLY & DELIVERY OF MATERIALS FOR LIVELIHOOD PROGRAM OF DOLE & PESO (MEAT PROCESSING AND CANDY MAKING) (GOODS 2019-012)" to IL FERNANDO GENERAL MERCHANDISE

RESOLUTION NO. GOODS G2019-012

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "SUPPLY & DELIVERY OF MATERIALS FOR LIVELIHOOD PROGRAM OF DOLE & PESO (MEAT PROCESSING AND CANDY MAKING)" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated October 14 - 21, 2019;

WHEREAS, in response to the said advertisements, only IL FERNANDO GENERAL MERCHANDISE from #62 Scout Medrinan, South Triangle, Quezon City, paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the bid proposal of IL FERNANDO GENERAL MERCHANDISE met the requirements and criteria during bid opening dated October 21, 2019;

WHEREAS, having only one bid proposal which passed the requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds IL FERNANDO GENERAL MERCHANDISE bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring IL FERNANDO GENERAL MERCHANDISE as the Single Calculated and Responsive Bid;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project *SUPPLY & DELIVERY OF MATERIALS FOR LIVELIHOOD PROGRAM OF DOLE & PESO*
- b) *(MEAT PROCESSING AND CANDY MAKING)* under project reference No. *GOODS 2019-012* to IL FERNANDO GENERAL MERCHANDISE;
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.


