BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF BRAND NEW SINGLE NEEDLE LOCKSTITCH MACHINE (HIGH SPEED)" to IL FERNANDO GENERAL MERCHANDISE

RESOLUTION NO. GOODS G2020-05

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "SUPPLY AND DELIVERY OF BRAND NEW SINGLE NEEDLE LOCKSTITCH MACHINE (HIGH SPEED)" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated June 23, 2020 to June 30, 2020;

WHEREAS, in response to the said advertisements, one bid document was submitted from IL FERNANDO GENERAL MERCHANDISE from #62 Scout Medrinan, South Triangle, Quezon City, the said bidder paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the bid proposal of IL FERNANDO GENERAL MERCHANDISE met the requirements and criteria during bid opening dated June 30, 2020;

WHEREAS, upon recommendation of TWG, the bid proposal of IL FERNANDO GENERAL MERCHANDISE was declared Single Calculated Bid for the project SUPPLY AND DELIVERY OF BRAND NEW SINGLE NEEDLE LOCKSTITCH MACHINE (HIGH SPEED);

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds IL FERNANDO GENERAL MERCHANDISE bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring IL FERNANDO GENERAL MERCHANDISE to pass the post-qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.






