**RESOLUTION NO. GOODS G2020-11**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for “ SUPPLY AND DELIVERY OF VENDING CART (LIVELIHOOD PROGRAM OF DOLE)” in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated September 16, 2020 to September 23, 2020;

WHEREAS, in response to the said advertisements, only one bid document was submitted from VMD TRADING from Zone VI, Iba, Zambales this said bidder paid the bid documents fee and submitted his letter of intent and application for eligibility and to bid;

WHEREAS, the bidder’s bid proposal met the requirements and criteria during bid opening dated September 23, 2020;

WHEREAS, upon recommendation of TWG, the bid proposal of VMD TRADING was declared Single Calculated Bid for the project SUPPLY AND DELIVERY OF EQUIPMENTS AND OTHER MATERIALS TO BE USED IN PRINTING DEPED LEARNING MODULES (FOR DISTRIBUTION TO VARIOUS SCHOOLS IN IBA, ZAMBALES, ELEMENTARY AND HIGH SCHOOL);

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds VMD TRADING bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring VMD TRADING to pass the post-qualification evaluation;


WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project **SUPPLY AND DELIVERY OF EQUIPMENTS AND OTHER MATERIALS TO BE USED IN PRINTING DEPED LEARNING MODULES (FOR DISTRIBUTION TO VARIOUS SCHOOLS IN IBA, ZAMBALES, ELEMENTARY AND HIGH SCHOOL)** under project reference No. **GOODS 2020-11** to **VMD TRADING**
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.






