BAC Resolution Recommending the Award of Project “SUPPLY AND DELIVERY OF INSTRUCTIONAL MATERIALS FOR DEPED ELEMENTARY TEACHERS OF LGU IBA” to VMD TRADING

RESOLUTION NO. GOODS G2019-015

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for “ SUPPLY AND DELIVERY OF INSTRUCTIONAL MATERIALS FOR DEPED ELEMENTARY TEACHERS OF LGU IBA” in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated November 12 - 19, 2019;

WHEREAS, in response to the said advertisements, two bid documents were submitted, first is from II. FERNANDO GENERAL MERCHANDISE from #62 Scout Medrinan, South Triangle, Quezon City second is from VMD TRADING from Zone 6, Iba, Zambales, all bidders paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the bid proposal of the two contractors met the requirements and criteria during bid opening dated November 19, 2019;

WHEREAS, upon recommendation of TWG, the bid proposal of VM TRADING was declared Lowest Calculated Bid for the project SUPPLY AND DELIVERY OF INSTRUCTIONAL MATERIALS FOR DEPED ELEMENTARY TEACHERS OF LGU IBA;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds VMD TRADING bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring VMD TRADING to pass the post-qualification evaluation;

WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To recommend the AWARD of the Project *SUPPLY AND DELIVERY OF INSTRUCTIONAL MATERIALS FOR DEPED ELEMENTARY TEACHERS OF LGU IBA under project reference No. GOODS 2019-015* to VMD TRADING
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.


