BAC Resolution Recommending the Award of Project “SUPPLY AND DELIVERY OF LAPTOP’S AND PRINTER FOR SANGGUNIANG BAYAN OF IBA OFFICE USE” to ALLY.COM COMPUTER NETWORK

RESOLUTION NO. GOODS G2020-03

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for “ SUPPLY AND DELIVERY OF LAPTOP’S AND PRINTER FOR SANGGUNIANG BAYAN OF IBA OFFICE USE” in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated February 25, 2020 to March 3, 2020;

WHEREAS, in response to the said advertisements, one bid document was submitted from ALLY.COM COMPUTER NETWORK from Baytan, Zone VI, Iba, Zambales, the said bidder paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid;

WHEREAS, the bid proposal of ALLY.COM COMPUTER NETWORK met the requirements and criteria during bid opening dated March 3, 2020;

WHEREAS, upon recommendation of TWG, the bid proposal of ALLY.COM COMPUTER NETWORK was declared Single Calculated Bid for the project SUPPLY AND DELIVERY OF LAPTOP’S AND PRINTER FOR SANGGUNIANG BAYAN OF IBA OFFICE USE;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds ALLY.COM COMPUTER NETWORK bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring ALLY.COM COMPUTER NETWORK to pass the post-qualification evaluation;


WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”


