The Procuring Entity shall allow the bidder to present its receipt of payment for the bid document fees during the bid-opening schedule of the project.

***Pre-Bid:***

6. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** will hold a Pre-Bid Conference on **December 1, 2022 2:00 PM** at **Office of Bids and Awards Committee, R. Magsaysay Ave., Zone I, Iba, Zambales**, which shall be open to prospective bidders.

***Receiving of Bids:***

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address **Office of Bids and Awards Committee, R. Magsaysay Ave., Zone I, Iba, Zambales**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause **16**.

***Bid-Opening:***

9. Bid opening shall be on **December 13, 2022 2:00 PM** at **Office of Bids and Awards Committee, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
