## **Invitation to Bid (IB) for:**

### **“SUPPLY AND DELIVERY OF MULTI-CAB FOR THE TRANSPORT OF PERSONNEL, EQUIPMENT, SUPPLIES, PRODUCTS AND MATERIALS AND TO SERVE AS AN IMMEDIATE RESPONSE DURING DISASTERS AND CALAMITIES, ESPECIALLY IN RELIEF OPERATIONS”**

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through the **LGSF - OTHER FINANCIAL ASSISTANCE TO LGU FY 2021 AND GENERAL FUND**, intends to apply the sum of **TWO MILLION FOUR HUNDRED THOUSAND PESOS AND 00/100 (₱2,400,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **“SUPPLY AND DELIVERY OF MULTI-CAB FOR THE TRANSPORT OF PERSONNEL, EQUIPMENT, SUPPLIES, PRODUCTS AND MATERIALS AND TO SERVE AS AN IMMEDIATE RESPONSE DURING DISASTERS AND CALAMITIES, ESPECIALLY IN RELIEF OPERATIONS” (GOODS 2022-14)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for the above Procurement Project. Delivery of the Goods is required within **the prescribed period in accordance with the terms specified in Section VI (Schedule of Requirements)** from the issuance of Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
2. Bidding will be conducted through open competitive bidding procedures using non-discretionary **“pass/fail”** criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
3. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from **10:00 AM to 4:00 PM**.
4. A complete set of Bidding Documents may be acquired by interested bidders on **November 10, 2022 to November 28, 2022** at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the

amount of **Five Thousand Pesos (₱5,000.00)**. The Procuring Entity shall allow the bidder to present its receipt of payment for the bid document fees during the bid opening schedule of the project.

***Pre-Bid Schedule***

1. The discretion of the **BIDS AND AWARDS COMMITTEE OF THE LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** is to hold a Pre-bid Conference on **November 17, 2022 10:00 AM at Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales** which shall be open to prospective bidders.

***Bid Submission Schedule***

2. Bids must be duly received by the BAC Secretariat through manual submission at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales on or before November 29, 2022 10:00 AM**. Late bids shall not be accepted.
3. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.

***Bid Opening Schedule***

4. Bid opening shall be on **November 29, 2022 10:00 AM at Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
