1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through the **LGSF ASSISTANCE TO MUNICIPALITIES (AM) OF C.Y. 2019** intends to apply the sum of **ELEVEN MILLION FIVE HUNDRED TWO THOUSAND PESOS AND 00/100 (P/ 11,502,000.00)**, being the Approved Budget for the Contract (ABC) to payments under the contract for **A. CONCRETING OF 366.0 LM LOWER ONSANG ROAD WITH 732.0 LM LINE CANAL (LOCAL ACCESS ROAD IN LOWER ONSANG BRGY. DIRITA BALOGUEN, IBA, ZAMBALES) B. CONCRETING OF 392.0 LM UPPER ONSANG – LITTLE BAGUIO ROAD WITH 392.0 LM LINE CANAL (LOCAL ACCESS ROAD IN UPPER ONSANG BRGY. DIRITA BALOGUEN, IBA, ZAMBALES)); INFRA 2019-011**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for **A. CONCRETING OF 366.0 LM LOWER ONSANG ROAD WITH 732.0 LM LINE CANAL (LOCAL ACCESS ROAD IN LOWER ONSANG BRGY. DIRITA BALOGUEN, IBA, ZAMBALES) B. CONCRETING OF 392.0 LM UPPER ONSANG – LITTLE BAGUIO ROAD WITH 392.0 LM LINE CANAL (LOCAL ACCESS ROAD IN UPPER ONSANG BRGY. DIRITA BALOGUEN, IBA, ZAMBALES)); INFRA 2019-011**. Completion of the Works is required **one hundred forty-one (141) days upon receipt of Notice to Proceed for project under item A and one hundred twenty (120) days for item B upon receipt of Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from **9:00 a.m.– 4:00 p.m.**

5. A complete set of Bidding Documents may be acquired by interested bidders on **October 21, 2019 to November 11, 2019** at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand pesos (P/ 25,000.00)**.
6. The **Local Government Unit of Iba, Zambales** will hold a Pre-Bid Conference on **October 29, 2019, 2:00 p.m.** at **Conference Room, 2nd Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**, which shall be open to prospective bidders who paid the Bid Documents Fee.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **November 11, 2019, , 2:00 p.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **November 11, 2019, , 2:00 p.m. at Conference Room, 2nd Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
