1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through **20 % DEVELOPMENT FUND OF 2020**, intends to apply the sum of A. SIX MILLION ONE HUNDRED NINETY-ONE THOUSAND FOUR HUNDRED SIXTY-SIX PESOS AND 00/100 (P/6,191,466.00) for CONCRETING OF 420.0 L.M. SITIO OLPOY ROAD - PHASE I AT BARANGAY AMUNGAN, IBA, ZAMBALES; B. FOUR MILLION FIVE HUNDRED TWELVE THOUSAND SEVEN HUNDRED EIGHTEEN PESOS AND 00/100 (P/4,512,718.00) for CONCRETING OF 360.0 L.M. TUGUE ROAD AT BARANGAY ZONE 1, IBA, ZAMBALES; being the Approved Budget for the Contract (ABC) to payments under the contract for each lot, Project Reference No. INFRA 2020-01. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for A. *CONCRETING OF 420.0 L.M. SITIO OLPOY ROAD - PHASE I AT BARANGAY AMUNGAN, IBA, ZAMBALES. Completion of the Works is required One Hundred Fourteen (114) days upon receipt of Notice to Proceed;* B. *CONCRETING OF 360.0 L.M. TUGUE ROAD AT BARANGAY ZONE 1, IBA, ZAMBALES, Completion of the Works is required Eighty-Six (86) days upon receipt of Notice to Proceed.* Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from **9:00 a.m. - 4:00 p.m.**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **December 28, 2019 to January 16, 2020** at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone 1, Iba, Zambales** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Twenty-Five Thousand Pesos (P/ 25,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than

Bid opening shall be on **January 16, 2020, 10:00 a.m.** at **Conference Room, 1st Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to information the affected bidder or bidders.
