Invitation to Bid (ITB) for:

A. "SLOPE PROTECTION OF TAKAR RIVER ALONG BRGY. ZONE 4 – (PHASE I) (BRGY. ZONE 4, IBA, ZAMBALES)" and B. "CONSTRUCTION OF FLOOD CONTROL STRUCTURE ALONG DOWNSTREAM OF BAYABA CREEK (PUROK 3, BRGY. AMUNGAN, IBA, ZAMBALES)"

1. The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES, through the A. 20% Development Fund and B. General Fund: Capital Outlay / LDRRM Fund intends to apply the sum of A. TWO MILLION ONE HUNDRED THIRTEEN THOUSAND FOUR HUNDRED SIXTY - EIGHT PESOS AND 00/100 (₱2,113,468.00) and B. SIX MILLION NINE HUNDRED EIGHTY - FIVE THOUSAND FOUR HUNDRED SEVENTY - SEVEN PESOS AND 00/100 (₱6,985,477.00) being the Approved Budget for the Contract (ABC) to payments under the contract for A. "SLOPE PROTECTION OF TAKAR RIVER ALONG BRGY. ZONE 4 – (PHASE I) (BRGY. ZONE 4, IBA, ZAMBALES)" and B. "CONSTRUCTION OF FLOOD CONTROL STRUCTURE ALONG DOWNSTREAM OF BAYABA CREEK (PUROK 3, BRGY. AMUNGAN, IBA, ZAMBALES)" (INFRA 2021 – 01). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES now invites bids for the above Procurement Project. Completion of the Works is required A. 90 Working Days and B. 120 Working Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES and inspect the Bidding Documents at the address given below from 9:00 AM to 4:00 PM.
5. A complete set of Bidding Documents may be acquired by interested bidders on January 08, 2021 to January 27, 2021 10:00 AM at Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (₱ 10,000.00). The Procuring Entity shall allow the bidder to present its receipt of payment for the bid document fees during the bid opening schedule of the project.
6. The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES will hold a Pre-Bid Conference on January 15, 2021 10:00 AM at Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address Conference Room, 1st Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales. Late bids shall not be accepted.

Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.


9. Bid opening shall be on **January 27, 2021 10:00 AM at Conference Room, 1st Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
