The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through the **20% DEVELOPMENT FUND** intends to apply the sum of **FIVE MILLION ONE HUNDRED SIXTY-SEVEN THOUSAND FOUR HUNDRED NINETY-FOUR PESOS AND 17/100 (P/ 5,167,494.17)**, being the Approved Budget for the Contract (ABC) to payments under the contract for **A. CONCRETING OF 575 LM BUAN ST. (HABANG FISHPORT-MARKET ROAD) AT PUROK 10, SITIO LANA O, BRGY. SAN AGUSTINE, IBA, ZAMBALES; B. CONSTRUCTION OF REINFORCE CONCRETE BOX CULVERT (RCBC) SINGLE BARREL - (2.40M X 2.40M X 5.0M) AT PUROK 1, SITIO LANA O, BRGY. SAN AGUSTINE, IBA, ZAMBALES; INFRA 2019-012**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for **A. CONCRETING OF 575 LM BUAN ST. (HABANG FISHPORT-MARKET ROAD) AT PUROK 10, SITIO LANA O, BRGY. SAN AGUSTINE, IBA, ZAMBALES; B. CONSTRUCTION OF REINFORCE CONCRETE BOX CULVERT (RCBC) SINGLE BARREL - (2.40M X 2.40M X 5.0M) AT PUROK 1, SITIO LANA O, BRGY. SAN AGUSTINE, IBA, ZAMBALES; INFRA 2019-012**. Completion of the Works-is required **eighty-six (86) days** upon receipt of Notice to Proceed for project under item **A** and **thirty-five (35) days** for item **B** upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from **9:00 a.m. – 4:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **October 28, 2019 to November 18, 2019** at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone 1, Iba, Zambales** and upon payment of the applicable fee

6. The Local Government Unit of Iba, Zambales will hold a Pre-Bid Conference on November 4, 2019, 2:00 p.m. at Conference Room, 1<sup>ST</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales, which shall be open to prospective bidders who paid the Bid Documents Fee.

7. Bids must be duly received by the BAC Secretariat at the address below on or before November 18, 2019, 2:00 p.m. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on November 18, 2019, 2:00 p.m. at Conference Room, 1<sup>st</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


