**Invitation to Bid for A. CONSTRUCTION OF EXTENSION ROOM AND  
ADDITIONAL ROOF CANOPY OF BARANGAY ZONE 2 MULTI-PURPOSE HALL; B.  
CONSTRUCTION OF E-LIBRARY AT BARANGAY AMUNGAN PLAZA, IBA,  
ZAMBALES;**

1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through **ANNUAL BUDGET C.Y. 2020 APPROPRIATION ORDINANCE 16, SERIES OF 2019**, intends to apply the sum of **TWO HUNDRED FIFTY-FOUR THOUSAND EIGHT HUNDRED TWO PESOS AND 00/100 (P/254,802.00)** for **A. CONSTRUCTION OF EXTENSION ROOM AND ADDITIONAL ROOF CANOPY OF BARANGAY ZONE 2 MULTI-PURPOSE HALL**; and **ONE MILLION TWO HUNDRED FIFTY-FOUR THOUSAND SEVEN HUNDRED FIFTY-FOUR PESOS AND 00/100 (P/1,254,754.00)** for **B. CONSTRUCTION OF E-LIBRARY AT BARANGAY AMUNGAN PLAZA, IBA, ZAMBALES** being the Approved Budget for the Contract (ABC) to payments under the contract Project Reference No. **INFRA 2020-04**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for **A. CONSTRUCTION OF EXTENSION ROOM AND ADDITIONAL ROOF CANOPY OF BARANGAY ZONE 2 MULTI-PURPOSE HALL; B. CONSTRUCTION OF E-LIBRARY AT BARANGAY AMUNGAN PLAZA, IBA, ZAMBALES**. *Completion of the Works is required Twenty-Four (24) days for project A and Eighty-eight (88) days both upon receipt of Notice to Proceed.* Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from **9:00 a.m. - 4:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **February 20, 2020 – March 10, 2020** at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P/ 5,000.00)**.  
  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Local Government Unit of Iba, Zambales** will hold a Pre-Bid Conference on **February 27, 2020, 2:00 p.m.** at **Conference Room, 2<sup>nd</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 10, 2020, 2:00 p.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.  
Bid opening shall be on **March 10, 2020, 2:00 p.m.** at **Conference Room, 1<sup>st</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
