1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through **GENERAL FUND OF 2019**, intends to apply the sum of **A. TWO MILLION SEVEN HUNDRED FIFTY THOUSAND EIGHT HUNDRED FIFTEEN PESOS AND 17/100 (P/2,750,815.17)** for CONSTRUCTION OF 535.6 LM DRAINAGE LINE CANAL AT BRGY. ZONE V, IBA, ZAMBALES; **B. EIGHT HUNDRED FORTY-EIGHT THOUSAND FIVE HUNDRED THIRTY-FIVE PESOS AND 71/100 (P/848,535.71)** for CONSTRUCTION OF 112.0 LM DRAINAGE LINE CANAL WITH 32.0 LM RC PIPE CULVERT AT 610 MM DIA. (SLAUGHTER HOUSE) AT PUROK 3, BRGY. STO. ROSARIO, IBA, ZAMBALES; **C. ONE MILLION TWENTY-EIGHT THOUSAND THREE HUNDRED NINETY-SEVEN PESOS AND 47/100 (P/1,028,397.47)** for CONSTRUCTION OF 153.0 LM DRAINAGE LINE CANAL WITH 12.0 LM RC PIPE CULVERT AT 610 MM DIA. AT CUEVAS ST. AND BURGOS ST. BRGY ZONE 1, IBA, ZAMBALES; **D. ONE MILLION FOUR HUNDRED THIRTY-ONE THOUSAND ONE HUNDRED FORTY-FIVE PESOS AND 00/100 (P/1,431,145.00)** for CONCRETING OF 152.0 LM LAOD RD - SITIO LIPIT, BRGY. DIRITA, IBA, ZAMBALES; being the Approved Budget for the Contract (ABC) to payments under the contract for each lot, Project Reference No. INFRA 2019-008. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for **A. CONSTRUCTION OF 535.6 LM DRAINAGE LINE CANAL AT BRGY. ZONE V, IBA, ZAMBALES. Completion of the Works is required Sixty (60) days upon receipt of Notice to Proceed; B. CONSTRUCTION OF 112.0 LM DRAINAGE LINE CANAL WITH 32.0 LM RC PIPE CULVERT AT 610 MM DIA. (SLAUGHTER HOUSE) AT PUROK 3, BRGY. STO. ROSARIO, IBA, ZAMBALES. Completion of the Works is required Thirty-Three (33) days upon receipt of Notice to Proceed; C. CONSTRUCTION OF 153.0 LM DRAINAGE LINE CANAL WITH 12.0 LM RC PIPE CULVERT AT 610 MM DIA. AT CUEVAS ST. AND BURGOS ST. BRGY ZONE 1, IBA, ZAMBALES. Completion of the Works is required Sixty (60) days upon receipt of Notice to Proceed; D. CONCRETING OF 152.0 LM LAOD RD - SITIO LIPIT, BRGY. DIRITA, IBA, ZAMBALES. Completion of the Works is required Thirty-Two (32) days upon receipt of Notice to Proceed.** Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from **9:00 a.m. - 4:00 p.m.**

5. A complete set of Bidding Documents may be acquired by interested bidders on **February 28, 2019 - March 19, 2019** at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (P/ 10,000.00).**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Local Government Unit of Iba, Zambales** will hold a Pre-Bid Conference on **March 7, 2019, 10:00 a.m.** at **Conference Room, 2<sup>nd</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 19, 2019, 10:00 a.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **March 19, 2019, 10:00 a.m.** at **Conference Room, 2<sup>nd</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
