Invitation to Bid for CONSTRUCTION OF ADDITIONAL CANOPY AT NEW IBA PUBLIC MARKET;

- The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES, through CONTINUING APPROPRIATION GENERAL FUND (CAPITAL OUTLAY), intends to apply the sum of THREE MILLION EIGHT HUNDRED SIXTEEN THOUSAND NINE HUNDRED EIGHTY-THREE PESOS AND 60/100 (P/ 3,816,983.60) for CONSTRUCTION OF ADDITIONAL CANOPY AT NEW IBA PUBLIC MARKET, being the Approved Budget for the Contract (ABC) to payments under the contract Project Reference No. INFRA 2019-005. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES now invites bids for CONSTRUCTION OF ADDITIONAL CANOPY AT NEW IBA PUBLIC MARKET. Completion of the Works is required One Hundred Twenty (120) days upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested bidders may obtain further information from LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES and inspect the Bidding Documents at the address given below from 9:00 a.m. - 4:00 p.m.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on January 28-February 16, 2019 at the Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P/ 5,000.00).
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The Local Government Unit of Iba, Zambales will hold a Pre-Bid Conference on February 4, 2019, 2:00 p.m. at Conference Room, 2nd Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat at the address below on or before February 18, 2019, 2:00 p.m. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on February 18, 2019, 2:00 p.m. at Conference Room, 2nd Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- The LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES reserves the right to reject 8. any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
