1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through GENERAL FUND, intends to apply the sum of FIVE MILLION NINE HUNDRED FIFTY-ONE THOUSAND EIGHT HUNDRED THIRTY-EIGHT PESOS AND 00/100 (P/5,951,838.00) for A. CONTINUOUS IMPROVEMENT OF NEW IBA PUBLIC MARKET FACILITIES AT DIRITA, IBA ZAMBALES (FRONT WING CANOPY, COMFORT ROOM AND REPAIR AND INSTALLATION OF WASTE WATER PIPE AND RAIN WATER PIPE LINE; B. FACILITY IMPROVEMENT OF RURAL HEALTH UNIT AT ZONE 6, IBA, ZAMBALES (CONSTRUCTION OF PATIENTS WAITING AREA AND RENOVATION OF COMFORT ROOM); C. IMPROVEMENT OF IBA HERITAGE PARK FACILITIES AT ZONE 5, IBA, ZAMBALES (COMFORT ROOM RENOVATION, LINED CANAL CONSTRUCTION AND STORAGE ROOM CONSTRUCTION) being the Approved Budget for the Contract (ABC) to payments under the contract for each lot, Project Reference No. INFRA 2020-08. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for *A. CONTINUOUS IMPROVEMENT OF NEW IBA PUBLIC MARKET FACILITIES AT DIRITA, IBA ZAMBALES (FRONT WING CANOPY, COMFORT ROOM AND REPAIR AND INSTALLATION OF WASTE WATER PIPE AND RAIN WATER PIPE LINE, Completion of the Works is required one hundred fifty (150) calendar days upon receipt of Notice to Proceed; B. FACILITY IMPROVEMENT OF RURAL HEALTH UNIT AT ZONE 6, IBA, ZAMBALES (CONSTRUCTION OF PATIENTS WAITING AREA AND RENOVATION OF COMFORT ROOM), Completion of the Works is required twenty-five (25) calendar days upon receipt of Notice to Proceed; C. IMPROVEMENT OF IBA HERITAGE PARK FACILITIES AT ZONE 5, IBA, ZAMBALES (COMFORT ROOM RENOVATION, LINED CANAL CONSTRUCTION AND STORAGE ROOM CONSTRUCTION), Completion of the Works is required ninety (90) calendar days upon receipt of Notice to Proceed.* Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and

Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from **9:00 a.m. - 4:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **September 17 – October 6, 2020** at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (P/ 10,000.00)**.  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **Local Government Unit of Iba, Zambales** will hold a Pre-Bid Conference on **September 24, 2020, 10:00 a.m.** at **Conference Room, 1<sup>st</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **October 6, 2020, 10:00 a.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.  
Bid opening shall be on **October 6, 2020, 10:00 a.m.** at **Conference Room, 1<sup>st</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
