**Invitation to Bid for INSTALLATION OF REINFORCE CONCRETE PIPE
CULVERT (RCPC) AND REHABILITATION OF SITIO BATO
BARANGAY ROAD.**

1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through **CONTINUING SUPPLEMENTAL 2017**, intends to apply the sum of ONE MILLION FIVE HUNDRED THOUSAND PESOS AND 00/100 (P/1,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for **INSTALLATION OF REINFORCE CONCRETE PIPE CULVERT (RCPC) AND REHABILITATION OF SITIO BATO BARANGAY ROAD**; Project Reference No. **INFRA 2018-015**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for *INSTALLATION OF REINFORCE CONCRETE PIPE CULVERT (RCPC) AND REHABILITATION OF SITIO BATO BARANGAY ROAD*, *Completion of the Works is required Twenty-One (21) days upon receipt of Notice to Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from **9:00 a.m. - 4:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **October 16 to November 5, 2018** at the **Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P/ 5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **Local Government Unit of Iba, Zambales** will hold a Pre-Bid Conference on **October 23, 2018, 10:00 a.m.** at **Conference Room, 2nd Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **November 5, 2018, 10:00 a.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **November 5, 2018, 10:00 a.m.** at **Conference Room, 2nd Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.


