- B. Concreting of 173.33 LM Purok 4, at Brgy. San Agustin, Iba, Zambales.**
- C. Concreting of 300 LM Posadas St. at Brgy. Palanginan, Iba, Zambales.**
- D. Concreting of 142 LM Bundang St. at Zone VI, Iba, Zambales.**

1. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES**, through **General Fund C.Y. 2017 under 20% Development Fund** intends to apply the sum of *1. TWO MILLION THREE HUNDRED THOUSAND PESOS AND 00/100 (P/2,300,000.00)* for concreting of 250 LM Merindo St. at Brgy. Amungan, Iba, Zambales; *2. ONE MILLION FORTY-FIVE THOUSAND PESOS AND 00/100 (P/1,045,000.00)* for Concreting of 173.33 LM Purok 4, at Brgy. San Agustin, Iba, Zambales; *3. THREE MILLION PESOS AND 00/100 (P/3,000,000.00)* for Concreting of 300 LM Posadas St. at Brgy. Palanginan, Iba, Zambales; *4. ONE MILLION THREE HUNDRED TWENTY ONE THOUSAND PESOS AND 00/100 (P/1,321,000.00)* for Concreting of 142 LM Bundang St. at Zone VI, Iba, Zambales; being the Approved Budget for the Contract (ABC) to payments under the contract for each lot, Project Reference No. 2018-001. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** now invites bids for *A. Concreting of 250 LM Merindo St. at Brgy. Amungan, Iba, Zambales, Completion of the Works is required FORTY-NINE (49) days upon receipt of Notice to Proceed; B. Concreting of 173.33 LM Purok 4, at Brgy. San Agustin, Iba, Zambales, Completion of the Works is required TWENTY-TWO (22) days upon receipt of Notice to Proceed; C. Concreting of 300 LM Posadas St. at Brgy. Palanginan, Iba, Zambales, Completion of the Works is required FIFTY-SIX (56) days upon receipt of Notice to Proceed; D. Concreting of 142 LM Bundang St. at Zone VI, Iba, Zambales, Completion of the Works is required THIRTY-TWO (32) days upon receipt of Notice to Proceed.* Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** and inspect the Bidding Documents at the address given below from 9:00 a.m. - 4:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested bidders on **March 2, 2018 to March 20, 2018** at the Office of Bids and Awards Committee, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales and upon payment of the applicable fee for the

Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (P/ 10,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. **The Local Government Unit of Iba, Zambales** will hold a Pre-Bid Conference on **March 9, 2018, 2:00 p.m.** at **Conference Room, 2<sup>nd</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **March 21, 2018, 2:00 p.m.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **March 21, 2018, 2:00 p.m.** at **Conference Room, 2<sup>nd</sup> Floor, Municipal Hall, R. Magsaysay Ave., Zone I, Iba, Zambales**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **LOCAL GOVERNMENT UNIT OF IBA, ZAMBALES** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
