BAC Resolution Recommending the Award of Project "PURCHASE OF TWO (2) UNITS OF CROSS-OVER UTILITY VEHICLE FOR OFFICIAL USE OF THE OFFICES OF THE ENGINEERING, TOURISM AND GENERAL SERVICES OFFICE LGU-IBA, ZAMBALES (GOODS 2017-016)" to TOYOTA BALINTAWAK INC.

RESOLUTION NO. GOODS G2017-016

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for PURCHASE OF TWO (2) UNITS OF CROSS-OVER UTILITY VEHICLE FOR OFFICIAL USE OF THE OFFICES OF THE ENGINEERING, TOURISM AND GENERAL SERVICES OFFICE LGU-IBA, ZAMBALES in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPS webpage continuously for seven (7) days dated September 21-27, 2017;

WHEREAS, in response to the said advertisements, only one intention to bid, from TOYOTA BALINTAWAK INC, was received by the BAC complete with proof of payment of bid documents fee. The other two bidders CARWORLD INC of San Fernando City and TOYOTA COMMONWEALTH of Quezon, City visited and downloaded the PhilGEPS of LGU Iba but did not submit any bid documents.

WHEREAS, the bid proposal TOYOTA BALINTAWAK INC met the requirements and criteria during bid opening dated October 10, 2017;

WHEREAS, having only one bid proposal which pass requirements and criteria during the bid evaluation and upon recommendation of TWG, BAC declared the same as the Single Lowest Calculated Bid;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification" and having only a single calculated bid the same shall undergo post-qualification;

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds TOYOTA BALINTAWAK INC bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring TOYOTA BALINTAWAK INC to pass their post qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

a) To recommend the AWARD of the Project Purchase of two (2) units of cross-over utility vehicle for official use of the offices of the Engineering, Tourism and General
