**BAC Resolution Declaring LYDELLE AGRO INDUSTRIAL SALES as the Single Calculated/Rated and Responsive Bidder and Recommending it for Approval to the Head of Procuring Entity**

**RESOLUTION NO. G2017-005**

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for Supply and Delivery of Rice Combined Harvester under the LPRAT-BUB 2016 in a conspicuous places of Municipality of Iba and on the website of PhilGeps continuously for seven (7) days dated April 26 - May 3, 2017;

WHEREAS, in response to the said advertisements, Lyndelle Agro Industrial Sales of San Juan Exention, Dinalupihan, Bataan represented by Eladio G. Pineda paid the bid documents fee and submitted its letter of intent and applications for eligibility and to bid.

WHEREAS, the bid proposal of Lyndelle Agro Industrial Sales meets the requirements and criteria during bid opening dated May 16, 2017 and has passed the non-discretionary "FAIL-PASS" criterion stipulated in Rule IX Section 30.1;

WHEREAS, Section 34.1 of the IRR requires "the Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification in order to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents;

WHEREAS, upon post qualification and evaluation of the bid proposal of Lyndelle Agro Industrial Sales was found substantially complying in the said bidding;

WHEREAS, the detailed Evaluation of bids conducted on May 17, 2017 and Post-Qualification dated May 18, 2017 resulted in the following:

WHEREAS, based on the foregoing finding stated above only Lyndelle Agro Industrial Sales, represented by Eladio G Pineda meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements; that bidder shall be considered for award.

WHEREAS, Section 36(a) *Single Calculated/Rated and Responsive Bid Submission shall be considered for award* if after the advertisement, only one prospective bidder applies for eligibility check, in accordance with the provisions of this IRR, and it meets the eligibility requirements or criteria, after which it submits a bid which is found to be responsive to the bidding requirements;

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To declare Lyndelle Agro Industrial Sales as the Single Calculated/Rated Responsive Bidder for the Supply and Delivery of Rice Combined Harvester under the LPRAT-BUB 2016.
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.




