**ORDINANCE NO. 001**  
**Series of 2014**

**PROHIBITING THE CONDUCT OF DROP BALL GAMES IN THE MUNICIPALITY OF IBA, ZAMBALES**

**Introduced by: Kgd. Salvador R. Redondo**

**Be it Ordained by the Sangguniang Bayan of Iba, Zambales**

**SECTION 1** - No person, natural or juridical, shall operate, maintain or conduct any drop ball game or any game of chance involving dropping of balls, wherein bets or wagers consisting of money, articles or representations of value are made.

**SECTION 2** - **Definition of Terms** – When used in this Ordinance, the following Terms shall mean:

- (a) Drop Ball - a form of gambling using one or more balls being drop in a basket and rolls to and stay in a flat surface divided by several lines where bets are placed. This includes “ping-pong”, except bingo and billiard games.

**SECTION 3** - **Rules and Regulations:**

- (1) No person shall allow any form of gambling though dropping of balls method, to be conducted or carried even on any real property that he/she owns or under his/her administration and control.
- (2) No person shall participate, directly or indirectly in the gambling mentioned herein.
- (3) No person shall possess any paraphernalia which have been used or about to be used, in drop balls game method.

**SECTION 4 - Penalty**

Any person who violates this ordinance shall be punished by a fine of not more than P/2, 000, or imprisonment not more than six (6) months, or both upon the discretion of the court.

**SECTION 5 - Repealing Clause** – All other Ordinances inconsistent with the provisions of this Ordinance are hereby repealed and modified accordingly.

**SECTION 6 - Effectivity** – This Ordinance takes effect upon approval.
