AN ORDINANCE RENAMING A PORTION OF J. GONZALES ST. IN POBLACION, IBA, ZAMBALES FROM RIZAL AVENUE TO SAGAPAN ROAD, AS FELIX Y. MANALO ST.

Introduced by Kgd. Alcade Fallorin

WHEREAS, one of the fruits of the phenomenal growth of the Iglesia ni Cristo founded by Felix Y. Manalo 99 years ago is the establishment a local chapel of the INC along J. Gonzales St., between Zone III and IV, Iba, Zambales;

WHEREAS, it is a declared policy of the Municipal Government of Iba, Zambales to recognize personality whose contribution to the development of the nation through selfless giving of his time, efforts and treasure for the sake of unity and spiritual growth of one of the biggest religious flock in the Philippines. Felix Y. Manalo is undoubtedly behind the unprecedented growth of the Iglesia ni Cristo to over 84 countries in the World;

WHEREAS, to honor the legacy and the outstanding contribution of Felix Y. Manalo, to the Nation, this Sanggunian is unanimous in naming a portion J. Gonzales from Rizal Avenue to Sagapan road, to Bro. Felix Y. Manalo St.;

WHEREFORE, on motion of Kgd. Alcade Fallorin, unanimously seconded, the Sangguniang Bayan in session assembled;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF IBA, ZAMBALES

Section 1 – A portion of J. Gonzales St. from Rizal Avenue to Sagapan Road or about 30 percent of J. Gonzales St. is hereby named FELIX Y. MANALO ST. The remaining portion of J. Gonzales St. from Rizal Avenue down to Magsaysay Avenue, Torres St., De la Rea St. and Arellano St. shall remain J. Gonzales St.

Section 2 – The street name shall be installed on both sides of Rizal Avenue to distinguish the portion of J. Gonzales St. and Felix Y. Manalo St.

Section 3 – It shall be the duty of the Office of the Municipal Mayor of Iba, Zambales to install the street marker bearing the name Felix Y. Manalo St. and J. Gonzales St.

Section 4 – Effectivity – This Ordinance takes upon approval and after consultation with the National Historical Institute.
