BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF OFFICE AND JANITORIAL SUPPLIES FOR VARIOUS OFFICES OF LGU – IBA," to I.L FERNANDO GENERAL MERCHANDISE

RESOLUTION NO. GOODS G2021-10

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "I.L FERNANDO GENERAL MERCHANDISE" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (12) days dated November 11, 2021 to November 26, 2021;

WHEREAS, in response to the said advertisements, only one bid document was submitted from I.L FERNANDO GENERAL MERCHANDISE from #62 Scout Medrinan St., South Triangle, Quezon City, this said bidder paid the bid documents fee and submitted her letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal met the requirements and criteria during bid opening dated November 29, 2021;

WHEREAS, upon recommendation of TWG, the bid proposal of I.L FERNANDO GENERAL MERCHANDISE was declared Single Calculated Bid for the project "SUPPLY AND DELIVERY OF OFFICE AND JANITORIAL SUPPLIES FOR VARIOUS OFFICES OF LGU – IBA,";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds I.L FERNANDO GENERAL MERCHANDISE bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring I.L FERNANDO GENERAL MERCHANDISE to pass the post-qualification evaluation;


WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.


