BAC Resolution Recommending the Award of The Project A. CONCRETING OF BENJAMINE FARIN SR. ST. AND CONSTRUCTION OF DRAINAGE LINED CANAL; B. CONCRETING OF LAMBINGAN ST. PHASE I AND CONSTRUCTION OF LINED CANAL (CONTINUATION); C. CONCRETING OF CAMP CONRADO D. YAP SERVICE ROAD to GMR CONSTRUCTION & SUPPLY

RESOLUTION NO. INFRA I2021-08

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the project A. CONCRETING OF BENJAMINE FARIN SR. ST. AND CONSTRUCTION OF DRAINAGE LINED CANAL; B. CONCRETING OF LAMBINGAN ST. PHASE I AND CONSTRUCTION OF LINED CANAL (CONTINUATION); C. CONCRETING OF CAMP CONRADO D. YAP SERVICE ROAD (INFRA 2021 – 08) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for (20) days dated May 08, 2021 to May 26, 2021;

WHEREAS, in response to the said advertisements, two bid documents were submitted, first is from GMR CONSTRUCTION & SUPPLY, and second is from KAEE CONSTRUCTION SERVICES; both bidders paid the bid documents fee;

WHEREAS, the bid proposal of GMR CONSTRUCTION & SUPPLY and KAEE CONSTRUCTION SERVICES met the requirements and criteria during bid opening dated May 26, 2021;

WHEREAS, upon recommendation of TWG, the bid proposal of GMR CONSTRUCTION & SUPPLY was declared Lowest calculated bid for both projects of the three projects “A. CONCRETING OF BENJAMINE FARIN SR. ST. AND CONSTRUCTION OF DRAINAGE LINED CANAL; B. CONCRETING OF LAMBINGAN ST. PHASE I AND CONSTRUCTION OF LINED CANAL (CONTINUATION); C. CONCRETING OF CAMP CONRADO D. YAP SERVICE ROAD”;

WHEREAS, Section 34.1 of IRR of 9184 requires that only “The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification”;

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds GMR CONSTRUCTION & SUPPLY documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR CONSTRUCTION & SUPPLY to pass the post qualification evaluation;

WHEREAS, Section 37.1.1 states that “The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed.”

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Projects *A. CONCRETING OF BENJAMINE FARIN SR. ST. AND CONSTRUCTION OF DRAINAGE LINED CANAL; B. CONCRETING OF LAMBINGAN ST. PHASE I AND CONSTRUCTION OF LINED CANAL (CONTINUATION); C. CONCRETING OF CAMP CONRADO D. YAP SERVICE ROAD* to GMR CONSTRUCTION & SUPPLY.
- b) To recommend to the Municipal Mayor of Local Government Unit of Iba the approval of the foregoing findings.




