"CONSTRUCTION OF LINED CANAL AT SITIO DOLIT (PHASE 2) (BRGY. PALANGINAN, IBA, ZAMBALES)" to GMR CONSTRUCTION & SUPPLY

RESOLUTION NO. INFRA I2021-02

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for the project A. "CONSTRUCTION OF LINED CANAL AT TALISAY ST. GOING THROUGH MAIN BARANGAY ROAD (PUROK 3, BRGY. STA. BARBARA, IBA, ZAMBALES)" and B. "CONSTRUCTION OF LINED CANAL AT SITIO DOLIT (PHASE 2) (BRGY. PALANGINAN, IBA, ZAMBALES)" (INFRA 2021 – 02) in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for (20) days dated January 08, 2021 to January 27, 2021;

WHEREAS, in response to the said advertisements, two bid documents were submitted, first is from ARCEGA CONSTRUCTION SERVICES then second is from GMR CONSTRUCTION & SUPPLY; all bidders paid the bid documents fee;

WHEREAS, the bid proposal of both bidders met the requirements and criteria during bid opening dated January 27, 2021;

WHEREAS, upon recommendation of TWG, the bid proposal of GMR CONSTRUCTION & SUPPLY was declared Lowest calculated bid for both projects of A. "CONSTRUCTION OF LINED CANAL AT TALISAY ST. GOING THROUGH MAIN BARANGAY ROAD (PUROK 3, BRGY. STA. BARBARA, IBA, ZAMBALES)" and B. "CONSTRUCTION OF LINED CANAL AT SITIO DOLIT (PHASE 2) (BRGY. PALANGINAN, IBA, ZAMBALES)";

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposals, the TWG finds GMR CONSTRUCTION & SUPPLY documents were substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring GMR CONSTRUCTION & SUPPLY to pass the post qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HoPE the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Projects A. "CONSTRUCTION OF LINED CANAL AT TALISAY ST. GOING THROUGH MAIN BARANGAY ROAD (PUROK 3, BRGY. STA. BARBARA, IBA, ZAMBALES)" and B. "CONSTRUCTION OF LINED CANAL AT SITIO DOLIT (PHASE 2) (BRGY. PALANGINAN, IBA, ZAMBALES)" to GMR CONSTRUCTION & SUPPLY.
- b) To recommend to the Municipal Mayor of Local Government Unit of Iba the approval of the foregoing findings.






