BAC Resolution Recommending the Award of Project "SUPPLY AND DELIVERY OF MEDICINES AND MEDICAL SUPPLIES FOR HEALTH SERVICES USE OF LGU-IBA, ZAMBALES" to IL FERNANDO GENERAL MERCHANDISE

RESOLUTION NO. GOODS G2021-03

WHEREAS, the LOCAL GOVERNMENT UNIT (LGU) OF IBA advertised/posted the Invitation to Apply for Eligibility and to Bid for "IL FERNANDO GENERAL MERCHANDISE" in three (3) conspicuous places of Municipality of Iba, in the LGU Website and on the PhilGEPs webpage continuously for seven (7) days dated April 09, 2021 to April 27, 2021;

WHEREAS, in response to the said advertisements, only one bid document was submitted from IL FERNANDO GENERAL MERCHANDISE from #62 Scout Medrinan St., South Triangle, Quezon City, this said bidder paid the bid documents fee and submitted her letter of intent and applications for eligibility and to bid;

WHEREAS, the single bid proposal met the requirements and criteria during bid opening dated April 27, 2021;

WHEREAS, upon recommendation of TWG, the bid proposal of IL FERNANDO GENERAL MERCHANDISE was declared Single Calculated Bid for the project SUPPLY AND DELIVERY OF MEDICINES AND MEDICAL SUPPLIES FOR HEALTH SERVICES USE OF LGU-IBA, ZAMBALES;

WHEREAS, Section 34.1 of IRR of 9184 requires that only "The Lowest Calculated Bid/Highest Rated Bid shall undergo post-qualification";

WHEREAS, upon post qualification and evaluation of the bid proposal, the TWG finds IL FERNANDO GENERAL MERCHANDISE bid documents to be substantially complying in the said bidding;

WHEREAS, the BAC approved and adopted the TWG Post Qualification Report declaring IL FERNANDO GENERAL MERCHANDISE to pass the post-qualification evaluation;

WHEREAS, Section 37.1.1 states that "The BAC shall recommend to the HGO the award of contract to the bidder with the Lowest Calculated and Responsive Bid, Highest Rated Responsive Bid, Single Calculated Responsive Bid or Single Rated Responsive Bid after the post-qualification process has been completed."

NOW, THEREFORE, We, The Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To recommend the AWARD of the Project **SUPPLY AND DELIVERY OF MEDICINES AND MEDICAL SUPPLIES FOR HEALTH SERVICES USE OF LGU-IBA, ZAMBALES** under project reference No. **GOODS 2021-03** to **IL FERNANDO GENERAL MERCHANDISE**
- b) To recommend for approval by the Municipal Mayor of the Local Government Unit of Iba, Zambales the foregoing findings.






